

# What is Liverpool Philharmonic?

### Liverpool Philharmonic enhances and transforms lives through music.

At the heart of our work is the critically-acclaimed Royal Liverpool Philharmonic Orchestra (the UK's oldest) and Choir; an extensive programme of participatory work with young people and others across our community; and presentation of almost 400 concerts and events each year at our home, Liverpool Philharmonic Hall.

#### Liverpool Philharmonic is rooted in our city.

We are central to Liverpool's cultural offering, being the largest music organisation and one of the largest cultural organisations in the city, employing over 300 people. As well as our work in Liverpool our Orchestra represent the city with performances and broadcasts across the UK and around the world.

The city's young people are a central focus of our work. Our In Harmony programme provides an intensive, daily music-making programme for over 1750 children in Everton and Anfield, North Liverpool, and we run more than 5,000 workshops and events in community settings for all ages across the City. The Liverpool Philharmonic Youth Company provides a range of opportunities for music making for young people, including the Liverpool Philharmonic Youth Orchestra, Liverpool Philharmonic Youth Choir, Children's Choirs, and Rushworth Young Composers programme. We work in partnership with the Mersey Care NHS Foundation Trust delivering programmes which support people in the Liverpool city region living with a range of mental health needs.

### Liverpool Philharmonic is committed to diversity and inclusion.

We attract world class artists to perform at Liverpool Philharmonic Hall and our small venue, Music Room, with a diverse programme of performances ranging from classical, contemporary, rock, pop, folk, roots, and jazz to comedy, film and spoken word. # **About Liverpool Philharmonic Youth Training Orchestra**

Liverpool Philharmonic Youth Training Orchestra is a brand new orchestra within Liverpool Philharmonic Youth Company's structure. Youth Training Orchestra is designed to be a friendly, supportive, non-auditioned orchestra for young musicians (aged approx. 8-15) playing at a Grade 2-4 standard. Youth Training Orchestra is a positive training ground for young musicians looking to learn the basics of orchestral musicianship and ensemble playing, performance health and wellbeing and performing as an orchestra. Positive social relationships, teamwork and friendship are at the heart of the Youth Training Orchestra experience for young people.

This ensemble will be the ideal ensemble for first time orchestra musicians to gain knowledge and experience of playing in an orchestra in a fun, inspiring and youth-voice led environment.

Youth Training Orchestra will play an exciting and diverse range of music- everything from classical and folk music, to movie and show tunes, with youth voice embedded in all artistic planning decisions.

Youth Training Orchestra will perform on stage at Liverpool Philharmonic Hall at least once a year, and will often perform side by side with members of the Royal Liverpool Philharmonic Orchestra.

Youth Training Orchestra will rehearse every Sunday during school term time, in Everton, Liverpool, from 2.30-4.00pm.

### What is the role?

#### **Principal Role**

Liverpool Philharmonic Youth Company provides individual and group opportunities for young musicians and artists, to develop skills and knowledge through performance, composition, concert visits and other creative opportunities.

The Youth Training Orchestra Artistic Director and Conductor works directly with the young orchestral musicians of Liverpool Philharmonic Youth Training Orchestra, and liaising with sectional tutors, mentors, the Youth Company operations team and reporting to Youth Company Producer.

The Youth Training Orchestra Artistic Director and Conductor will also be responsible for:

- Working with the Youth Company Producer to select appropriate repertoire.
- Working collaboratively with the Youth Company Producer to create a comprehensive orchestral training programme for young musicians, and ensuring its success in its integral first twelve months.

Youth Training Orchestra rehearsals take place in Everton, Liverpool, every Sunday evening during school term time, 2.30-4.00pm.

# **Key Responsibilities**

#### **ARTISTIC DIRECTION AND PLANNING:**

- Working collaboratively with the Youth Company Producer to select ability appropriate, diverse and engaging repertoire each term, adhering to set deadlines to ensure effective and smooth operation of the ensemble
- Working collaboratively with the Youth Company Producer to develop the Youth Training Orchestra model to ensure musical progression to Youth Academy Orchestra, and one day Youth Orchestra, by identifying key areas of learning needed for young musicians
- When required, working collaboratively with Youth Academy Orchestra and Youth Orchestra conductors to ensure a uniform and cohesive approach to progression throughout the orchestral progression route of Youth Company
- Attending termly artistic direction meetings with Youth Company Producer, and reporting back on the ensembles' progress and areas for development

#### **CONDUCTING**

- Providing musical leadership and conducting to Youth Training Orchestra during their weekly rehearsals
- Being able to provide informed advice and constructive feedback to young musicians on how to improve and develop their playing and orchestral skills during their weekly rehearsals
- Ensuring all rehearsals and performances remain positive, inclusive, social and fun for young musicians at all times.
